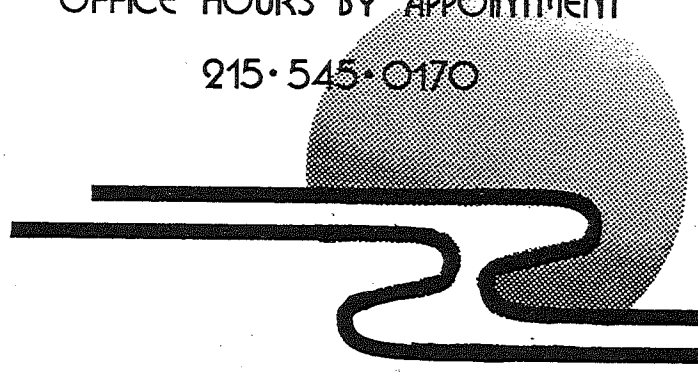

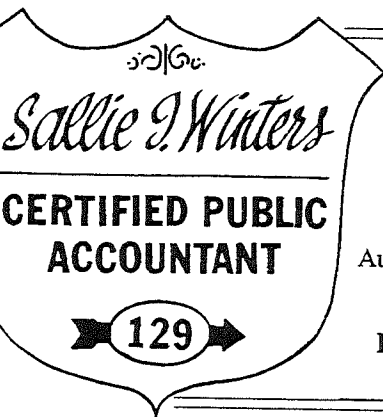

was on medical leave at Cedars at  
the time of his death.

Although Taraborelli was well  
aware of the restrictions and sever-  
ity of his illness, he greeted his  
days with an unaltered sense of  
hope, a tremendous capacity for  
humor and love, and a generosity  
toward others true to his lifelong  
gift for empathy and compassion.

Taraborelli was politically ac-  
tive for many years, most recently  
with AIDS Project/LA and in  
fighting anti-gay state ballot  
propositions. He was committed  
to voter registration drives and was  
a supporter of ACT UP (AIDS  
Coalition To Unleash Power).

Taraborelli was pre-deceased by  
his father, brother, mother, stepfa-  
ther and Philadelphia native and  
good friend, Dr. Neil Mogul. He is  
survived by his longterm lover,  
Dan Meade, whose love and  
strength inspired much of  
Taraborelli's capacity for laugh-  
ter. Also surviving are his niece  
and nephew, cousins, aunts, uncles  
and many loving friends.
