Chuck Wheeler

Chuck Wheeler of 125 League St. lost his personal fight with AIDS on Tuesday,

June 23, at Graduate Hospital.

Chuck had most recently been employed by the City of Philadelphia's Office of

Housing and Community Development as a Management Analyst. In that capacity, he continued the neighborhood and community development work to which he devoted his professional life during the past 12 years in Philadelphia.

Prior to his work for OHCD, he had worked as the Director of Training for the Institute for the Study of Civic Values. He served as the Executive Director of the Philadelphia Clearinghouse from 1981 through 1987. During that time he transformed the Clearinghouse from insolvency to a United Way agency that provided constituent services to many mainstream non-profit agencies as well as grass roots community groups.

After being raised in Philadelphia and Bucks County, Chuck left in 1966 to complete his high school education in Birmingham, England. He received his undergraduate degree from the University of Virginia in 1970 as an Echols scholar. After a two-year period during which he lived in the District of Columbia and worked as the Director of a Crisis Intervention Hotline Service, he moved to Toronto, Canada, to attend York University. Chuck was awarded a Masters Degree in Social and Political Thought from that university.

Returning to Philadelphia from Canada in 1979, his primary work involved taking the message of community self determination and empowerment to people through organizations like the Philadelphia Clearinghouse, the Institute for the Study of Civic Values, and the city's Office of Housing and Community Development.

"She is excellent," said Lt. Col. Gregory Angstman, Mindt's commanding officer and the man who initiated the investigation against her. "Pam has provided just outstanding social work support to the National Guard. I've had no questions about her abilities to perform for the military or her commitment to provide mental health support to the National Guard."

But Angstman said there is nothing he can do. The U.S. military has excluded gays and lesbians for more than 50 years.

"It's not my responsibility to set the policies of the military," he said. "It's my responsibility to follow the policies."

Under the policy against homosexuality, an average of about 1,500 men and women were discharged annually from 1980 to 1990—a total of 16,919.

If she is discharged, Mindt says she plans to sue in federal court.

"Ilove the military," she said.
"But it saddens me to think
I'm a member of an organization that would get rid of me
because I love a woman."
